Terms and Conditions

1. Daily Rates Include:

Services of PH, hunting license, full accommodation, laundry, all meals and soft drinks. Special tastes will be created for, if enough notice is given in advance. Trackers, skimmers and camp staff. Field preparation of trophies. Transport to and from Port Elizabeth airport. All transport within the hunting area. One 4x4 wheel drive hunting vehicle per PH.

2. Daily Rates Do Not Include:

Hire of firearms (\$30 per day and ammunition extra).
Telephone calls and 100% surcharge.
Hotel accommodation before and after safari.
Dipping, packing and shipment of trophies.
Gratuities to camp staff, trackers, skimmers and PH.
Any extra activities for example Addo Elephant National Park, Ocean drives etc.

3. Reservations and Payment:

A deposit of 50% of the **HUNT** is required to confirm the booking. Final payment of the balance of the **HUNT**. Plus all trophy fees are due at the end of the **HUNT**.

- 4.** Trophy fees are applicable to animals killed or wounded and lost. Trophies/Animals on the package deals and mentioned in this contract are not guaranteed. Dog fees (\$350) will be charged if there is need to hunt with them for example Lynx, Bushpig etc.
- 5.** Cancellations will be accepted if a replacement for your reservation can be booked. If not, the deposit will be forfeited.
- 6.** **Xtreme Safaris** reserves the right to change conditions, prices and/or terms herein without notice. (Tariff based on current prices).
- 7. Liability:** Whilst all reasonable precautions are taken to ensure the safety and good health of **CLIENTS**, no liability will be accepted by **Xtreme Safaris** of injury or illness during and/or after safari. Vehicles are maintained in the highest mechanical order and we regret that we cannot be held responsible for any breakdown which may occur.

Taxidermist:** whilst all reasonable precautions are taken to ensure the quality and good care of trophies, no responsibility will be accepted by **Xtreme Safaris** for loss or damage to trophies, through fire or theft, and we regret that we cannot be held responsible for trophies once they have been delivered and signed over to the taxidermist for preparation or dipping and packing.
- 9.** **CLIENTS** are required to arrange their own personal, travel, all-risks, hunting and medical insurance. **CLIENT** represents and warrants to **Xtreme Safaris** that his physical and mental condition is such that he or she is capable of making the **HUNT**.
